Terms and Conditions

1. The sealed and signed offer must reach the Managing Director/CEO of DCCL by **28th March 2025**, no later than **15:00 hours**. Alternatively, you can email password-protected quotations to **procurement@dccl.bt**. Bids will be opened on the same day at **15:30 hours (BST)**. Late offers will not be accepted.
2. Bidders must quote rates as per the given specifications. Items not meeting these specifications will be rejected.
3. **Bid Security**
 - a. Submit Bid Security of **10%** of the quoted amount in the form of Cash Warrant/Demand Draft/Bank Guarantee, addressed to MD/CEO, DCCL, Nganglam, valid for **two months** from the bid opening date. It will be retained as performance security until the contract expires. If delivery is delayed by more than one month, the order will be canceled, and the security will be forfeited. Alternatively, you may submit a Bid Securing Declaration Form (FORM NO. 1).
 - b. Bid Security will be forfeited:
 - i. If a bidder withdraws their bid during its validity period.
 - ii. If the successful bidder does not accept corrections to the bid price.
 - iii. If Bid Securing Declaration is forfeited, the bidder must provide the bid security amount as Cash Warrant or Bank Guarantee within **14 days** of DCCL's notification. Non-compliance will bar the bidder from doing business with DCCL.
4. Bidders should not quote rates if specifications are unclear. Clarify with the Procurement Section before quoting the rate.
5. The final delivery point is the DCCL Store. Delivery must be completed within **30 days** of the purchase order. Materials must meet specifications; rejected items must be replaced at the supplier's cost.
6. Prices must include all taxes and duties in India. Bhutan taxes and duties will be covered by DCCL. Bank charges are the supplier's responsibility.
7. Late delivery will incur **Liquidated Damages of 0.3% per day**, up to a maximum of **10%** of the total value of delayed items.
8. Rejected materials must be replaced or removed within **10 days** of rejection notice. Failure will incur a penalty of **0.3% of the item's value per day** for up to 30 days. Beyond 30 days, the items will be seized, and the order will be cancelled with forfeiture of performance security.
9. The warranty period is **one year or 18 months** from delivery/usage, unless specified otherwise. Manufacturer warranties will apply where provided.
10. Orders will be placed based on the **lowest evaluated bid**.
